The Mohawk College of Applied Arts and Technology Board of Governors' Annual General Meeting was called to order at 9:02 p.m.

1. **Annual General Meeting, June 14, 2000**

It was moved by Tom Behroozi and seconded by Tom Atterton that the minutes of the Annual General Meeting of June 9, 1999 be approved. Carried unanimously. **(MOTION 2000AGM1)**

2. **All Acts, Proceedings, Contracts, Bylaws, Appointments, Elections and Payments Since June 1999 Annual General Meeting**

It was moved by Maxine Wypych and seconded by Rick Sterne that it be resolved that all the acts, proceedings, contracts, by-laws, appointments, elections and payments, enacted, made, done and taken by the Board of Governors and Officers of the Mohawk College of Applied Arts and Technology since the last annual meeting, as recorded in the minutes of the College, be approved and ratified. Carried unanimously. **(MOTION 2000AGM2)**

3. **Audited Financial Statements for 1999/2000**

It was moved by Bob Peeling and seconded by Jim Koyanagi that it be resolved that the audited financial statements of Mohawk College for 1999/2000 be received as presented and that the Chair of the Finance Committee (Olga Delvecchio) and the Chair of the Audit and Operational Review Committee (Rebecca Jamieson) be authorized to sign the statements on behalf of the Board. Carried. unanimously. **(MOTION 2000AGM3)**

Olga Delvecchio asked the President whether or not all withholdings with respect to employee remittances and other government requirements have been met. The President responded that all withholdings with respect to employee remittances and all other government requirements have been met.

Olga Delvecchio asked the President if there were any other issues, at this time, which she wished to disclose to the Board of Governors. The President responded that there were no issues to disclose to the Board.

4. **Appointment of Auditors of Mohawk College**

It was moved by Rebecca Jamieson and seconded by Linda Brown that it be resolved that the appointment of the company of BDO Dunwoody LLP as auditors of the Mohawk College of Applied Arts and Technology (as approved by the Board of Governors at the June 14, 2000 meeting) be confirmed for the next financial year, 2000/2001, at a fee acceptable to the Audit and Operational Review Committee. Carried unanimously. **(MOTION 2000AGM4)**

5. **Mohawk College Board Officers (September 1, 2000 to August 31, 2001)**

It was moved by Olga Delvecchio and seconded by Rick Sterne that the slate of Mohawk College Board Officers for the term September 1, 2000 to August 31, 2001 (as approved by the Board at the May 10, 2000 meeting) be ratified:
